### PROGRAM DESCRIPTION:

A one-day conference is being held Oct. 25, 2013 to highlight the importance of developing partnerships among public and private providers throughout the state and across the continuum of care to optimize recovery for individuals with an addiction and/or mental illness. Several innovative programs will be presented that demonstrate the creative and collaborative work of hospitals and community providers across the care continuum, leading to enhanced outcomes for individuals affected by addiction and mental illness. The keynote speaker will provide an inspirational perspective related to healthcare's potential. Breakout sessions will also provide attendees flexibility related to their areas of interest and a diverse program that promotes practical application of evidence-based practices.

The conference is sponsored by the Ohio Department of Mental Health and Addiction Services and the Ohio Hospital Association (OHA).
