OHIO MITS TRAINING WORKSHOPS

Ohio MITS Training Workshops

Ohio Medicaid, in partnership with Hewlett-Packard (HP), will offer training sessions from May 30 – June 21, 2012 to assist Medicaid behavioral health providers in making the transition to directly submitting Medicaid claims to the Ohio Medicaid Information Technology System (MITS) effective July 1, 2012. This provider training, which will all be web based, is targeted to providers certified by the Ohio Department of Mental Health (ODMH) and /or the Ohio Department of Alcohol and Drug Addiction Services (ODADAS) and enrolled as Ohio Medicaid providers.

Please take a moment to review the list of dates and times for training workshop sessions to determine which best meets your organizational needs.

Web-based training

The Webinars will be conducted using a tool called HP Virtual Rooms (VR). There is no phone line associated with the webinar. Instead, the sound associated with the training will come through the internet via the desktop's or laptop's sound system

NOTE: Not all audio cards are compatible to the VR voice over IP so we strongly recommend that your agency attend a sound testing session PRIOR to your scheduled training webinar.

Before registering for the training, please work with your system administrator to determine if your computer system will allow you to participate in the Webinar:

- On the 'Minimum requirements' page, verify the requirements for both:
 - HP Virtual Meeting Room and HP Virtual Training Room
 - Audio and Video Over the Web

Class size limitations

Each registrant will be assigned one license that provides access to the Webinar on one computer. Everyone who plans to attend the Webinar through their own computer will need to register individually. If, however, an organization plans to show the Webinar presentation to an entire group, using one projector, then only one registration is needed.
