

**OHIO DEPARTMENT OF JOB AND FAMILY SERVICES
INTERAGENCY SUBGRANT/SUBRECIPIENT AGREEMENT
AMENDMENT 2**

This is Amendment 2 to the Interagency Subgrant/Subrecipient Agreement between the State of Ohio, Department of Job and Family Services (hereinafter referred to as "ODJFS") and Ohio Department of Mental Health (hereinafter referred to as "ODMH"), signed by ODJFS on July 25, 2011, and amended effective September 27, 2011.

1. The following Definitions are hereby added, to read as follows:

SPMI Severe and persistent mental illness is the term used by mental health professionals to describe adult mental illnesses with severe and complex symptoms that require ongoing treatment and management.

SED Serious emotional disturbances is the term used by mental health professionals to describe individuals under 18 years of age, who have significant emotional disturbances and are at the greatest risk for needing services based upon diagnosis, duration of impairment and level of functioning.

2. ARTICLE III, Section G, Paragraph 1, Data Sharing, is hereby amended to read as follows:

1. ODMH and ODJFS agree to share electronic data on a continual basis, as is feasible and agreeable to each agency. Such access shall be provided to ODJFS by ODMH, according to the conditions agreed to by both state agencies, in such a way as to ensure the integrity and effective and efficient administration of the Medicaid and SCHIP programs and other related development activities involving the two agencies. ODMH recognizes that ODJFS may grant access to data provided by ODMH to another entity in accordance with applicable privacy and confidentiality provisions. The two agencies agree that any research, proposals, presentations or program applications relating to the SPMI or SED populations which have been developed will not be released without the express consent of the other party.

3. All other terms of the Agreement are hereby affirmed.


