Health Home Service Payment Information

Ohio Medicaid pays for Health Home services based on submission of Fee-for-Service (FFS) monthly claims. The monthly case rate covers each Health Home service component.

Separate Medicaid claims may be submitted for:

- Community behavioral health services **except** for Community Psychiatric Support Treatment (CPST);
- Other interventions and treatment service (e.g., primary care or specialty services) through existing Medicaid payment systems (Managed Care Plans or Fee-for-Service).

No double billing for care management services

If a consumer is enrolled in a Health Home, activities formerly provided under CPST are encompassed within the Health Home service and are no longer reimbursable for that consumer. Case management or other types of care coordination services cannot be reimbursed for clients receiving Health Home services (i.e., CPST, alcohol or other drug case management provided at and by the Health Home provider, Managed Care Plan case management, etc.).
