The supplemental application is required only for those Ohio community mental health services providers that are certified by the Ohio Department of Mental Health/Ohio Department of Mental Health and Addiction Services* that are eligible and seeking to become Health Homes for individuals with serious and persistent mental illness (SPMI).

* The Ohio Department of Mental Health (ODMH) and the Ohio Department of Alcohol and Drug Addiction Services (ODADAS) will become the Ohio Department of Mental Health and Addiction Services (Ohio MHAS) effective July 1, pending legislative approval. Statutory and regulatory authority, and all functions, duties, responsibilities, obligations, assets and liabilities of ODMH and ODADAS immediately and automatically will be consolidated into Ohio MHAS.
