

**OHIO DEPARTMENT OF JOB AND FAMILY SERVICES
INTERAGENCY SUBGRANT/SUBRECIPIENT AGREEMENT
AMENDMENT 3**

This is Amendment 3 to the Interagency Subgrant/Subrecipient Agreement between the State of Ohio, Department of Job and Family Services (hereinafter referred to as "ODJFS") and Ohio Department of Mental Health (hereinafter referred to as "ODMH"), signed by ODJFS on March 24, 2010, amended effective June 17, 2010 and amended effective September 28, 2010.

1. ARTICLE III, Section A , Paragraph 5 is hereby amended to read as follows:

ODMH shall establish mandatory requirements for Boards and CMH agencies which provide mental health services covered under this Agreement to ensure compliance with the provisions of this Agreement and all the requirements of federal or state law or rules governing the Medicaid and SCHIP programs. Such requirements may be implemented through the "Community Medicaid Services Agreement" (Attachment 1) executed between ADAMH/CMH Boards and CMH agencies. With the implementation of an ODJFS OAC rule or rules implementing a change in Ohio's community mental health treatment component of Ohio's Medicaid program, any reference in an already executed open ended "Community Medicaid Services Agreement" relating to the change is nullified as the requirements of the OAC prevail.

2. ARTICLE III, Section F, Paragraph 1, g. is hereby amended to read as follows:

ODMH Medicaid overpayment recoveries of ODMH providers, including any recoveries made by the Collections Enforcement Section of the Office of the Ohio Attorney General, or through the provider reconciliation process, will be disbursed in the following manner:

1. Remit only the federal share to ODJFS; or
 2. If ODMH recovers less than one hundred percent (100%) of the federal share, ODMH shall remit to ODJFS the entire amount that was recovered.
 3. Any amounts recovered under this agreement that are not reimbursement of the federal share shall no longer be considered Medicaid funds subject to governance of laws or regulations of the Medicaid program.
3. All other terms of the Agreement are hereby affirmed.
