

**OHIO DEPARTMENT OF JOB AND FAMILY SERVICES
INTERAGENCY SUBGRANT/SUBRECIPIENT AGREEMENT
AMENDMENT 4**

This is Amendment 4 to the Interagency Subgrant/Subrecipient Agreement between the State of Ohio, Department of Job and Family Services (hereinafter referred to as "ODJFS") and Ohio Department of Mental Health (hereinafter referred to as "ODMH"), signed by ODJFS on March 24, 2010, amended effective June 17, 2010, amended effective September 28, 2010 and amended effective October 18, 2010.

1. ARTICLE II, Section E, Paragraph 3, a. is hereby amended to read as follows:
 3. eFMAP
 - a. Upon receipt of a valid ISTV from ODMH, ODJFS will transfer eFMAP amounts, as calculated by ODJFS in accordance with ARRA through the quarter ending June 30, 2011, unless the ARRA is repealed prior to June 30, 2011.

2. ARTICLE III, Section F, Paragraph 3, a. is hereby amended to read as follows:
 - a. Prior to accepting any transfer of eFMAP funding, ODMH will attest that it will follow terms and conditions imposed on ODJFS by Sections 5001(f)(1), (f)(2), (f)(3) and (g)(2) of the ARRA, as modified by Section 1905(cc) of the Social Security Act as amended by Section 10201(c)(6) of the Patient Protection and Affordable Care Act, Pub. L. 111-148. Because Boards are subrecipients of ODMH under this agreement, compliance with these sections of ARRA is also mandatory upon them without the necessity of additional contract language or other Board level assurance statements or agreements. ODMH will assure that such compliance by the Boards occurs.

3. All other terms of the Agreement are hereby affirmed.


