Rules for Certified Community Mental Health Agencies

The Ohio Department of Mental Health has promulgated amended, rescinded and new OAC rules governing deemed status and reciprocity, certification procedure, and provisions of certification, which will be effective November 24, 2011. The main goal of these revisions is to offer regulatory reduction. The Department will hold a webinar to discuss the changes on Friday, December 2, at 10:30 am. Rules for Private Psychiatric Hospitals, Community Mental Health Agencies, Residential Facilities, and Mental Health Boards

The Ohio Department of Mental Health has promulgated amended, rescinded and new OAC rules governing consumer rights and grievance procedure, which will be effective March 1, 2012. One goal of these rule revisions was to develop a common set of rights for consumers across treatment settings. The Department plans to schedule webinar training for these rules during January, 2012. The date will be announced when available.
