Subject: Proposed Rule Amendments for:

- o 5122-36 Residential State Supplement Program

The Ohio Department of Mental Health and Addiction Services (OhioMHAS) is proposing the following Ohio Administrative Code rule actions. Please review these draft proposed rule actions and provide any comments you may have **by October 14, 2015**.

In conjunction with the Ohio Department of Medicaid, OhioMHAS is updating the rules implementing the Residential State Supplement program (RSS.) As part of this update the OhioMHAS rules will reflect a new allowable fee and personal needs standard. Allowable fees for RSS living arrangements are increased to one thousand one hundred dollars a month for all living arrangements, at the same time the personal needs allowance is being standardized to two hundred dollars per month. The rules are also being updated to be consistent with the application process used in conjunction with the Department of Medicaid.

Due to the amount of change in the rules, the rules are being rescinded and refiled as new.
