SFY 2015 Specialized Docket Projects

The Ohio Department of Mental Health and Addiction Services (OhioMHAS) funds certified specialized dockets that target participants with a drug addiction or dependency. These allocations defray a portion of the payroll costs associated with the employment of new or existing court personnel who support offenders in complying with treatment. For State Fiscal Year 2015, OhioMHAS awarded more than \$4 million for 109 specialized dockets. OhioMHAS anticipates funding additional dockets as they become certified.
