PROGRAM DESCRIPTION

The Ohio Department of Mental Health and Addiction Services (OhioMHAS) will host its one-day, biennial conference for behavioral health care providers, which will emphasize a proactive prevention and early intervention approach to many behavioral health care issues. This conference will provide practical, evidence-based strategies that providers can apply in their practice. Keynote Sharlene Graham Boltz will speak about preventing violence through the use of threat assessments. During a lunch presentation, County Commissioner Judy Dodge will discuss the city of Dayton’s approach and success related to combating the opiate crisis. Prevention-related break-out sessions will occur throughout the day.

Speakers

Opening Remarks: Lori Criss, Director, OhioMHAS

A native of eastern Ohio, Lori Criss has been engaged in the behavioral health field since 1992. Her experience includes working for the Ohio Commission on Minority Health and Amethyst, Inc. Prior to coming to OhioMHAS, Lori served as the Chief Executive Officer of the Ohio Council of Behavioral Health & Family Services Providers.

Ms. Criss holds bachelor's and master's degrees in social work from The Ohio State University. She graduated from SAMHSA's 2010-2011 Women's Addiction Services Leadership Institute, a year-long, nationally selective, intensive program designed to build leaders for the nation's behavioral health field. Lori has most recently served on the Advisory Board to Ohio's Criminal Sentencing Commission, the National Council for Behavioral Health's Addiction Policy Committee, and Ohio's Housing and Homeless Collaborative. She is a former board member for the National Alliance for Recovery Residences and served as the Principal Advisor for Ohio Recovery Housing.



Keynote: Sharlene Boltz



Sharlene Boltz is a Professor of Law at Salmon P. Chase College of Law, Northern Kentucky University. She received her B.A. from Brown University and her J.D. from the University of Michigan Law School. Prior to teaching, Professor Boltz practiced law as a trial attorney in the Office of General Counsel for the U. S. Department of Agriculture in Washington, D.C., and in private practice in New Orleans. She began her teaching career at Chase College of Law in the area of commercial law in 1991. In 1997, she became the first African-American woman to receive tenure and promotion to full professor in the 108-year history of the law school. Professor Boltz served as the Associate Dean for Academic Affairs from 2000 to 2003, becoming the first African-American to serve as an administrator of the law school. She currently teaches in the commercial law and domestic violence law areas, specializing in threat assessment and behavioral analysis of abusive and controlling behavior. In 2011, she completed her training with Gavin DeBecker & Associates' Advanced Threat Assessment and Case Management Academy, and in 2012, she graduated from the FBI Citizen's Academy. She is the author of two instructional case files on domestic human trafficking.

Lunch Presentation: Judy Dodge

During her career in public service, Montgomery County Commissioner Judy Dodge has served in a variety of capacities. She worked as the Assistant Court Administrator for the Montgomery County Domestic Relations Court during her initial run for office to become County Recorder in 2000, re-elected in 2004. She was first elected as County Commissioner in 2006, then again in 2008, 2012 and 2016.

Judy has consistently aimed to be a voice for vulnerable populations, and has been instrumental in the passage of two human services levies. She now serves on the steering committee for the Community Overdose Action Team, which has become a nationally recognized model for how to collectively turn the tide on the ongoing public health crisis. She has also helped establish a local food policy coalition and a regional sustainability center.
