

## New SUD 1115 Stakeholder Advisory Committee and Updated BH Provider Resource Documents

### **Stakeholder Advisory Committee for Ohio's SUD 1115 Waiver**

On Friday December 20<sup>th</sup>, Ohio Department of Medicaid (ODM) and Ohio Department of Mental Health and Addiction Services (OhioMHAS) Directors Maureen Corcoran and Lori Criss will convene a newly formed Stakeholder Advisory Committee to provide input regarding the implementation of Ohio's SUD 1115 waiver.

Members of the Stakeholder Advisory Committee have been selected to represent Ohio geography, various types and levels of services, Medicaid beneficiaries, and the wide variety of stakeholders concerned about substance use treatment in Ohio. Members will be asked to seek and convey feedback from their respective constituencies. All committee meetings will be open to the public via in-person or webinar participation.

The first meeting of the Stakeholder Advisory Committee will be held on **Friday, December 20<sup>th</sup>, from 11:00 am – 1:30 pm in room C621 at the Ohio Department of Medicaid, 50 W. ### **Updated Behavioral Health Provider Resource Documents**

#### **BH Provider Manual**

The BH Provider Manual has been updated to reflect one addition to an eligible place of service and to update language regarding dependently licensed clinicians. The specific changes in this most current manual version are:

- For H0005, SUD group counseling, place of service 99 (community) has been added as an allowable place of service.
- Prior version indicated dependently licensed practitioners did not have to enroll in Medicaid. That was corrected with this version.

### **BH Provider Billing Resources**

- ODM staff have updated the “Supervisor, Rendering, Ordering Fields” spreadsheet to reflect the August 1, 2019 policy change that made physician orders optional for RN nursing services.
- ODM staff have also corrected a typographical error in the “2019 ICD-10 DX Code Groups BH Redesign” spreadsheet in which ICD 10 code F11.10 was listed twice and F11.11 was omitted.
