## >>> Marijuana Education Resources



Drug-Free Action Alliance (DFAA) has compiled resources from Nationwide Children's Hospital of Columbus and the Arizona Chamber of Commerce to assist in community education and prevention efforts around marijuana. Nationwide Children's Hospital recently released a report that was published in the *Clinical Pediatrics Journal* titled, "[Marijuana Exposure Among Children Younger Than Six Years in the United States](#)." Summary findings show that the rate of marijuana exposures for children under six years of age rose by 147.5 percent between 2006 and 2013 in states with legalized marijuana. According to researchers, 75 percent of the children with marijuana exposure were under three years of age. The Arizona Chamber of Commerce released a Policy Brief titled, "[Recreational Marijuana: Is the Case for Legalization Going Up in Smoke?](#)" The report delves into issues dealing with marijuana legalization such as short- and long-term health effects, overestimated economic benefits and impact on employers. ## >>> Office of Health Transformation Update: Ohio Tops Nation in Prosecuting Medicaid Fraud

As reported by the [Dayton Daily News](#), investigations of health care providers billing taxpayers while neglecting or defrauding Medicaid patients have more than doubled in Ohio since 2010 and led to 124 indictments last year, more than in any other state. The increase in fraud investigations and indictments is likely not related to increased caseload -- the number of providers billing Medicaid has remained fairly constant at around 92,000 -- but because the state is getting better at catching the fraud that

already existed. "The Ohio Medicaid Fraud Control Unit is doing as good or better than any in the country," said Lloyd Early, special agent in charge of Medicaid fraud in the Ohio Attorney General's Office.
