

The Ohio departments of Developmental Disabilities and Mental Health and Addiction Services today announced FY 2016 [Strong Families, Safe Communities](#) youth crisis grantees during a virtual town hall titled *Kids in Crisis: Preventing Tragedies Through Earlier Intervention*. DODD Director John Martin and OhioMHAS Director Tracy Plouck shared information about the origins of the project and announced this year's grantees, while project partners shared successes and lessons-learned as well as how best practices are being shared across the state. >>> Smart Choices Promising Problem Gambling Prevention Seminars Offered

On behalf of OhioMHAS, Drug Free Action Alliance presents [Smart Choices](#), regional problem gambling prevention model trainings at no cost to participants. The *Smart Choices* program addresses the potential for problem gambling in elementary school age children through college age students. Research indicates that 80 percent of students between the ages of 12 and 17 have gambled for money in the past year. Adolescents' problem gambling prevalence rates are at least double that of adults. By making the program part of a community/school based effort, the intent is to build on resiliency skills and teach/reinforce refusal skills critical to today's youth and responsible decision making. This training will be facilitated by: Carl Robertson, M.RE, M.Div; Prevention Manager at the Maryland Center of Excellence on Problem Gambling.
