## >>> New Report Shows Continued Progress in Promoting Responsible Opioid Prescribing



Opioid prescribing in Ohio declined for a fourth consecutive year in 2016, according to a [newly released report](#) from the State Board of Pharmacy's Ohio Automated Rx Reporting System (OARRS). Between 2012 and 2016, the total number of opioids dispensed to Ohio patients **decreased by 162 million doses** or 20.4 percent, from a peak of 793 million doses to 631 million doses. The number of opioid prescriptions provided to Ohio patients decreased by 20 percent during the same period. The report also finds a 78.2 percent decrease in the amount of people engaged in the practice of "doctor shopping" since 2012. Additionally, the use of OARRS continued to increase, reaching an all-time high of 24.1 million requests in 2016.

RSS provides financial assistance to adults who have increased needs due to a disability that is not severe enough to require long term care in an institution, such as a nursing home or hospital. The Department is excited to announce that program enrollment has reached approximately 2,300 individuals statewide. Complete program applications will continue to be reviewed in the order received.
