>>> Trainings to Focus on New Methadone Regulations

The Ohio Department of Mental Health and Addiction Services (OhioMHAS) today final filed new Methadone Regulations, contained in Ohio Administrative Code Chapter 5122-40, which will be effective June 1, 2017. Any Ohio provider utilizing methadone to treat opiate addiction must be licensed by OhioMHAS as a methadone program, and certified by OhioMHAS to provide the non-Methadone treatment services. OhioMHAS will provide three different webinar trainings on the new rules. Note: each webinar will be recorded. >>> Waiting List Law Effective July 1, 2017

Beginning July 1, 2017, Ohio Revised Code section (ORC) [5119.362](#) requires that all community addiction services providers maintain a waiting list for opioid and co-occurring drug addiction services and recovery supports. The waiting list data is due to OhioMHAS monthly by the 30th day. (For example, the waiting list data collected in July would be due to the department by Aug. 30.)

ORC 5119.363 requires OhioMHAS to adopt rules regarding the duties of community addiction services providers related to the waiting list. Click to review a draft of the [administrative rule](#) and the [appendix](#) that have been filed with the Joint Commission on Agency Rule Review. [Draft instructions](#) for the waiting list along with a [reporting template](#) that captures the required elements of the administrative rule and statute have been developed. Providers may submit the information to OhioMHAS using the form, or they may send the data in through an extract.
