The Ohio Department of Mental Health and Addiction Services (OhioMHAS) today named Lisa lannotta as Chief Legal Counsel and Deputy Director overseeing the Office of Legal Services and the department's bureaus of Licensure and Certification and Pre-Admission Screening and Resident Review. Iannotta brings more than 30 years' experience in legal affairs to the department. She began her career in state government with the Auditor of State's Office, serving as Assistant Legal Counsel and Deputy Chief Legal Counsel for more than 15 years. She then worked for the Attorney General's Office as both Chief of the Public Protection Division and as Chief Counsel before serving as Director of Administrative Services for Delaware County. Iannotta then returned to state government serving as Chief Legal Counsel for the Ohio Department of Administrative Services. Most recently, she served as Section Chief for Collections Enforcement with the Ohio Attorney General's Office. Iannotta earned a bachelor's degree in Criminal Justice from the University of Delaware and her Juris Doctorate from Capital University Law School.
