## >>> PPE DELIVERY

Governor DeWine announced April 29 that the State of Ohio has shipped 4.1 million pieces of personal protective equipment (PPE) to local emergency management agencies (EMA) across Ohio. Although this is not the first shipment of PPE, this is the largest one-time distribution of PPE from the state of Ohio to the local EMAs in Ohio history. The shipment includes: 500,000 N95 masks; 850,000 face shields; 750,000 surgical-type masks; and 2 million non-medical gloves. The PPE will be distributed locally by county EMAs to nursing homes, jails, congregate living facilities, hospitals, and first responders. The PPE was secured through the work of the Ohio Department of Administrative Services, JobsOhio, Ohio Department of Health, and Ohio Emergency Management Agency. ## >>> Operation Face Mask

A new, grassroots effort is underway to assist medical facilities, health care providers (including behavioral health care settings, ACFs, etc.), and first responders who do not have face masks available. [Operation Face Mask](#), launched by Air Force veteran and nurse Jenn Andrade and local partners, is recruiting individuals with sewing skills to donate homemade masks to be distributed. The group encourages donors to follow the [recommended guidance](#) from the CDC for sewing a homemade face mask.
