# **ODMH Announces Recipients of \$1 Million Grant for Repairs at Adult Care Facilities**

More than 100 ODMH-licensed facilities receiving needed funds

More than 100 Adult Care Facilities, which house people with various disabilities throughout the state, recently were awarded funds from a grant administered by the Ohio Department of Mental Health to make critical repairs to maintain and improve the habitability and safety of their facility. These facilities provide room, board and personal care for individuals who reside in the community, but need assistance with daily living. Residents may have a variety of disabilities, including mental illness.

ODMH received 184 pre-applications from eligible ACFs, and 115 have met all the requirements and will be receiving funding for one or more of their identified priorities. Eligible ACF owners applied for amounts ranging from \$2,000 to \$10,000 for each eligible facility. ODMH identified four categories for funding requests for projects to preserve the longevity of the facility: structural defects, heating and plumbing defects, electrical hazards and safety features.

ODMH assumed licensure of the nearly 700 ACFs in Ohio with the signing of the state's Fiscal Year 2012-13 budget. In February 2012, the Ohio Housing Finance Agency (OHFA) approved ODMH to administer the \$1 million Adult Care Facility Critical Repair Grant from Ohio Housing Trust Fund to pay for health and safety repairs at Adult Care Facilities (ACFs) throughout the state. This significant award enables ODMH to assist these ACFs in making essential repairs needed to maintain their structural integrity.

"Safe and affordable housing options are critical to the well-being of people with disabilities," ODMH Director Tracy J. Plouck said. "By ensuring that Ohio's housing stock is well-maintained, we not only enable vulnerable individuals to live with dignity, we also ensure that they are not placed in more restrictive and costly care settings."

ODMH will maintain all eligible repair projects that were not funded on a prioritized waiting list. If any funds remain available after processing the currently funded projects, the remaining funding will be committed to additional projects.


