COVID-19 UPDATES

Phase 1A remains open with an acknowledgement that vaccinating congregate care facilities and high-risk healthcare providers will take more time. Continue collaborating with your local health departments as they work hard to distribute the vaccine supplies currently available.

Phase 1B is also open for Ohioans aged 65 and above and those with severe congenital or developmental disorders, along with employees of K-12 schools that wish to remain or return to in-person or hybrid learning, and [Ohioans born with or who have early childhood conditions that are carried into adulthood](#), which put them at a higher risk for adverse outcomes due to COVID-19. Vaccine information is [available in plain language](#) for those Ohioans with developmental disabilities.

[Vaccine.coronavirus.ohio.gov](https://vaccine.coronavirus.ohio.gov) is an online resource for Ohioans to learn which providers received a COVID-19 vaccine allotment and how to contact them. If you or someone you know is eligible to receive a vaccine in Phase 1B, they should use this tool.



- Each week, Ohio receives approximately 140,000 doses of COVID-19 vaccines to use on Ohioans in Phase 1B. With 2.2 million Ohioans in this group, the weekly impact gradually helps Ohio on the road back. [Average weekly vaccinations \(JPG\)](#)

- We have to do all that we can to continue protecting ourselves and others from contracting and spreading COVID-19. It's important that we continue to wash our hands regularly, maintain social distancing, and wear our masks anytime we are out with others.
